# **BACKGROUND / STATUTORY AUTHORITY**

In the 2006 gubernatorial campaigns, the major veterans' organizations sent letters to all candidates for the office of Governor. The candidates were asked specific questions to determine what their campaign plans were for various veterans' issues in the state of Ohio, if they were elected. One such question was how the candidates stood on creating an Ohio Department of Veterans' Affairs. For several years, the major veteran's organizations, through their convention resolutions, had recommended to the Governor and state legislature that they create an Ohio Department of Veterans' Affairs. These resolutions were not acted upon by state government. Governor Strickland responded positively to this question and strongly supported the creation of an Ohio Department of Veterans' Affairs in his campaign promises to Ohioans. As a result, he issued Executive Order 2007-11S on May 30, 2007 (Appendix A) to establish a Veterans Study Council to provide recommendations regarding the creation of the Ohio Department of Veterans Affairs.

# **EXECUTIVE SUMMARY / OVERALL FINDINGS**

Unanimously, the Veterans Study Council recommends the establishment of an Ohio Department of Veterans Affairs with a cabinet level director.

The Council was initially divided into four subcommittees to research and report on different areas covered in Executive Order 2007-11S (Appendix A). The four areas were: projected services, enhance veterans' benefits, evaluate other states' structure, and current services provided. The recommendations provided in this final report reflect the findings of each subcommittee as voted upon by the complete Council.

# **RECOMMENDATIONS**

- 1. To establish an Ohio Department of Veterans Affairs with a cabinet level Director.
- 2. To develop, produce, and distribute statewide marketing programs to assist in advising veterans on their benefits.
- 3. To fund, staff and allow the absorption/assimilation of all veteran related programs within the State of Ohio and have complete operational control and authority over all state programs and federal funding pertinent to veterans' affairs and oversight of government entities purported to assist veterans and/or their dependents with all programs and activities being handled under the umbrella of one office, centralizing the accountability and tracking of all services provided to Ohio's veterans from any source.
- 4. To establish agreements with other agencies ODJFS, Adjutant General, etc, to ensure that all veterans are provided access to benefit information, ODVA will work closely with the United States Department of Veterans' Affairs to track federal benefits being provided to Ohio's veterans and their dependants and will contract for the same if necessary. ODVA will be given statutory authority to maintain all DD214s. ODVA will be given authority to require all state and county agencies and nursing homes, to screen all veterans or veterans' dependants to determine their status. Establishment of an ODVA Advisory Board, the Governor's Women Veterans Advisory Committee be given statutory appointment and a seat on the ODVA Advisory Board if it is established.
- 5. To Include under ODVA: GOVA duties, Education, Training Programs, War Orphans Scholarship, DVOPS/LVRS, Ceremonies, Hall of Fame, Veterans Home, Grant Writing, Legislative Liaison, Compliance Monitoring, Marketing, Employment, Homeless Veterans Program, Incarcerated Veterans Program along with a 'catch all' for any programs not mentioned.
- To be a central clearinghouse for information to and oversight of personnel providing services to the veterans of the State of Ohio related to delivering veterans benefits.
- To have regulatory oversight responsibility and authority to ensure that all staff maintain any continuing educational requirements necessary in their assigned tasks, proficiency, and demonstrate good service provision to clientele.
- 8. To provide regulatory oversight over training and certification for County Veteran Service Commissioners (VSC) and County Veteran Service Officers

- (CVSO), and will track and review all training and accreditation for other personnel providing services to the veterans of the State of Ohio.
- To establish uniform reporting standards for all personnel providing services to the veterans of the State of Ohio, including but not limited to VSCs, CVSOs, and Veteran Service Organizations.
- 10. To require that all personnel providing VA claims services to veterans of the State of Ohio must meet continuing educational requirements and certifications; either federal, veterans service organizations and/or state.
- 11. To assist in improving training for all personnel providing VA claims services to the veterans of the State of Ohio. Some web-based training should be developed with the assistance of those entities requiring training as a supplemental training method to face-to-face training in limited circumstances.
- 12. To ensure that in the event personnel providing services to the veterans of the State of Ohio are found to be in non-compliance with the mandates of Ohio law, ODVA shall have the authority to recommend corrective action.
- 13. To adequately fund Veteran Service Organizations performing a state function of statewide claims assistance to Ohio veterans and dependants if recognized for such purposes by the U. S. Department of Veterans Affairs.
- 14. To ensure individual county veterans service commissions and veterans' service offices will maintain their individuality, control their own funding, and manage their own internal business under the provisions of Title 59, ORC.
- 15. To maintain the current status of the Ohio National Guard, separate from the Ohio Department of Veterans' Affairs.

# Executive Order 2007-11S

Establishing a Study Council to Provide Recommendations Regarding the Creation of the Ohio Department of Veterans Affairs

- Ohio Has A Rich History of Its Citizens Serving in the Armed Forces.
   Ohio has a proud history of its sons and daughters serving in the National Guard and our nation's armed forces. In fact, Ohio is home to over a million veterans and thousands more military personnel who are serving today.
- 2. Ohio Must Eusure That Its Veterans Receive the Services and Support They Need. For too long, Ohio's veterans have not been receiving the support or services they deserve. Every Ohioan who has served in our nation's armed forces and their families must be connected to the benefits that they have earned and to which they are entitled.
- Establishment of the Veterans Study Council. To ensure that Chio's veterans are receiving the support that they need, I hereby order the establishment of a Veterans Study Council (the "Study Council").
  - a. The Role of the Study Council. The mission of the Study Council is to:
    - Identify existing State services that are provided to veterans and their families
    - Examine ways in which State services to veterans and their families can be aligned and reorganized into a new cabinetlevel department
    - Lock at ways to enhance the use of federal resources and communicate effectively with the federal Department of Veterans Affairs; and

- iv. Compile these findings in a report of recommendations that I will receive by no later than December 31, 2007
- b. The Composition of the Study Council. The Study Council shall be composed of twenty-two members:
  - A chairperson of the Study Council, appointed by the Governor
  - American Legion Department of Ohio Commander or his designee
  - iii. AMVETS Department of Ohio Commander or his designee
  - iv. Army and Navy Union USA Department of Ohio Commander or his designee
  - v. Catholic War Veterans Department of Ohio Commander or his designee
  - vi. County Veterans Service Officers President or his designee
  - vii. Disabled American Veterans Department of Ohio Commander or his designee
  - viii. Governor's Advisory Committee on Women Veterans Chair or her designee
  - ix. Governor's Office of Veterans' Affairs Advisory Committee Chair or his designee
  - Jewish War Veterans Department of Ohio Commander or his designee
  - xi. Korean War Veterans Department of Ohio Commander or his designee
  - xii. Marine Corps League of Ohio Commandant or his designee
  - xiii. Military Order of the Purple Heart Department of Ohio Commander or his designee
  - xiv. Veterans of Foreign Wars Ohio State Commander or his
  - xv. Veterans Service Commissioners President or his designee
  - xvi. Vietnam Veterans of America Ohio State President or his designee
  - xvii. The Adjutant General or his designee
  - xviii. The Attorney General or his designee
  - xix. Two (2) members of the Ohio Senate, one appointed by the President of the Senate and one appointed by the Minority Leader of the Senate
  - xx. Two (2) members of the Ohio House of Representatives, one appointed by the Speaker of the House and one appointed by the Minority Leader of the House

- c. Assessment of Financial Resources Available to Ohio's Veterans. In support of the Study Council's mission, I direct the Office of Budget and Management to perform a financial review of services provided to veterans by state entities and agencies, including, but not limited to, the Ohio Veterans Homes Agency, the Governor's Office of Veterans Affairs, the Department of Rehabilitation and Corrections, the Ohio Department of Job and Family Services, the Adjutant General, the Department of Education, the Board of Regents and the Attorney General.
- d. Support Staff and Compensation. The Governor's Office of Veterans' Affairs shall provide all administrative, financial, and staff support for the Study Council and no member of the Study Council will receive compensation.
- I signed this executive order on May 30, 2007 in Columbus, Ohio and it will expire on my last day of office unless rescinded before then.

# APPENDIX B

# OPEN MEETING LAWS AND ROBERTS RULES OF ORDER

The study council will follow the Ohio open meeting laws and Roberts rules of order as follows:

- (A) Each organization as specified in the Executive Order shall name a representative(s), and an alternate(s), to the study council to represent the organization by July 9<sup>th</sup> and to forward the recommendations to the director of the governor's office of veterans' affairs.
- (B) The quorum requirements of the governor's veterans' study council is established at fourteen (14) members.
- (C) A two-thirds (14 members) majority of the study council is required to approve or oppose any issue before the study council. A simple majority of study subcommittee members is required to approve or oppose any issue
- (D) The study council meetings shall be conducted under Robert's rules of order
- (E) The chairperson and vice chairperson for the study council shall be appointed by the governor. The staff of the governor's office of veterans' affairs shall perform the duties of secretary, as a non-voting member.
- (F) The council shall meet every two weeks at a time and place determined by the chairperson of the veterans study council.
- (G) The chairperson of the study council may call a special meeting of the council as necessary.
- (H) Changes in the rules for the operation of the veterans study council requires a twothirds vote of the council.
- (I) All votes shall be roll call and in rotating order.
- (J) Executive Summaries of the study council should be sent to members of the council at least seven days prior to the next regularly scheduled study council meeting.
- (K) Any motions to be considered from a sub-committee by the study council shall be made in writing, and be a permanent part of the official minutes of said meetings(s).



The Minutes were accepted unanimously with a change recommended by Representative Fessler to note her comments on the allocation of funds by the state to the veterans service organizations (motioned by John Maurer and seconded by Frank Williams).

The Agenda was accepted unanimously (motioned by William Boettcher and seconded by William Miller).

#### **Bills and Communications:**

A letter is needed from the Army Navy Union and the Marine Corps League in reference to the change verbally mentioned with the alternates assigned.

A letter has been received by the Ohio State Association of Veterans Service Commissioners but needs clarification as there are two primaries listed (Robert Stewart and Michael Stith) and one alternate (Daniel Weist).

Korean War Veterans representative and alternate are both ill and will not be in attendance.

#### Old Business:

Rules presented at previous meeting were accepted unanimously (motioned by John Maurer and seconded by Frank Williams).

#### **New Business:**

Office of Budget Management (OBM) – Susan Ackerman shared veteran spending and veteran programs that are funded by the state and federally (please see attached handouts). The state funds currently allocated to the Governor's Office of Veterans' Affairs just covers the salary/benefits of its four employees. The Ohio Veterans Hall of Fame is funded within the Ohio Veterans Home budget (\$125,000 for FY08 and FY09). A federal vs. state funding breakdown will be provided by OBM along with the numbers of Disabled Veteran Outreach Program (DVOP) and Local Veterans Employment Representatives (LVER) that have not been filled over the last few years in comparison with the decrease of federal funding.

How Other States are Organized – The Governor's Office of Veterans Affairs Director, Tim Espich, provided a breakout of several states' Veterans Affairs offices (see attached slide handout). His presentation only consisted of structure and not benefits. The states covered were chosen due to population compared to Ohio with the addition of Kentucky which was included due to the Director being familiar with their system. Numbers provided for population are mathematical projections from the USDVA. Don Lanthorn noted that Alaska provides grants to the veteran organizations and, in turn, the organizations prepare and advocate all veterans' claims for the state. William Boettcher would like to see the percentage of claims that are filed through the state POAs vs. the organizations.

It was asked if there is a veteran population census or other single source of contact information for veterans within the state. Director Espich explained that the USDVA numbers only consist of those veterans that are in the USDVA system receiving pension or compensation; there is no other source for those outside of the system. Due to the Privacy Act, the USDVA cannot release the information they do have; any mailings conducted by the state from the USDVA information must be conducted in cooperation with the USDVA. The DD214s that are submitted to the Governor's Office of Veterans Affairs could become a database but addresses submitted on those documents are not always accurate. When asked what his take is on the council and those involved becoming upset regarding changes Director Espich explained that the council is here to find the best way to serve veterans, and he is certain they will do just that. Questions were asked regarding statistics on: claims approved vs. declined, which counties are most proactive in getting veterans benefits, and the breakdown of county vs. claims and/or organization vs. claims. The USDVA only breaks down claims by service organizations, statistics for claims submitted to

the USDVA are skewed due to veterans processing claims in counties other than their own and organizations processing claims through other states.

Regarding outreach Director Espich stated Ohio is at ground zero, the cost of a welcome home packet, a strategic plan, PSAs or even a newsletter cannot be covered under the current budget support. Many individual counties have their own outreach programs.

# Bill McLemore, Deputy Assistant Secretary for Intergovernmental & International Affairs – The United States Department of Veterans Affairs Claims Process

Deputy Assistant Secretary McLemore's biography was provided. Throughout the discussion the Deputy Assistant Secretary referred to the 'study' (Analysis of Differences in Disability Compensation in the Department of Veterans Affairs, report prepared by the Institute for Defense Analyses).

The study consists of consolidated data from the last 35 years. Ohio is last among the 50 states in the average dollars received for compensation claimed. Three components impact the statistics: the mix of eligible veterans, the rate of filing claims, and the adjudication process. The only component that the state can impact is the rate of filing claims. Per the study the states with more funds for the veterans have higher rates, more Power of Attorneys and a partnership between the USDVA and state services (i.e. accredited officers at the regional offices and VA Medical Centers for observation) equal better results. The expenditure report within the study does not include pension, emergency assistance or medical care.

The USDVA has three different areas of claim processing: initial claim, increase claim, and previously denied and re-opened claim. When veterans move from county to county or state to state the Regional Office must begin gathering records all over again. Currently the VA has a backlog of approximately 800,000 claims.

The Cleveland Regional Office takes in approximately 2200 claims per month. Their efficiency rating is at 85% while many other Regional Offices are well above 100%. New leadership is coming into the Cleveland Regional Office and the office just hired 24 and next month will hire 20 more new rating officers. It will take 2-3 years to train/qualify. Todd Webber, of the Cleveland Regional Office, noted that the new rating officers will be placed on basic cases during their training period to assist with backlog.

Ohio only has about 60% of applying veterans represented by a Power of Attorney. The state needs a relationship with the Regional Office and to have a presence at the facilities. Ohio knows the laws and has more qualified County Veterans Service Officers than other states. Ohio needs to submit more claims to increase their ratings.

Concerns of the council include:

How will more applications/claims help Ohio when Ohio is already so far behind? Why do veterans in Ohio with the same claim/problem as another veteran (inside or outside of Ohio) receive a different percentage of compensation?

Two years is unacceptable, how do you tell a veteran that they must wait two more years for their rating?

Representative Fessler asked the Deputy Assistant Secretary to define the problem and to give the solution. The Deputy Assistant Secretary noted that the problem is that Ohio is concerned with Ohio being the last in the study and the solution is Ohio needs to review reports of other states and what they do. Fessler wants the federal laws or administrative rules that are considered to be an impediment to the time the VA turns around an application and details and information on the training and accreditations for the rating officers. The Deputy Assistant Secretary agreed to supply her with the requested information.

Attached recommendations were provided. Discussion followed. It is recommended that the Ohio National Guard (ONG) be handled separately. Discussion continued on the status of a guardsman regarding benefits. It was confirmed that this would need to be verified and fully understood prior to changes in creating a veterans' affairs department. Tim Espich added currently the Governor's Office of Veterans Affairs has no control over the ONG members, they do overlap and assist and currently have a strong relationship with the Adjutant General's Department.

Thomas Burke added that the incarcerated veterans were not addressed in the subcommittee report. Currently there are approximately 4,000-5,000 veterans in the prison system (sentenced to six or more months for felony convictions), what happens with these veterans affects the state budget. Currently the Governor's Office of Veterans Affairs, VA, Vietnam Veterans of America (VVA) and the Ohio Department of Rehabilitation and Corrections are spearheading a system to follow a veteran through the prison system in order to assist them when they are released with employment, housing and retrieving their veterans' benefits. Currently the VVA has ten incarcerated chapters and they receive countless letters from those incarcerated that will be homeless once released. Where should this be discussed? This is an ongoing problem. OIF/OEF veterans are beginning to enter the prison systems, PTSD is increasing with these veterans due to the type of war they are fighting and the multiple deployments they face. John Maurer agreed that this is a distinct sub-group that needs special assistance; Jon Warmeling also agreed that it would need to also go under the Ohio Department of Veterans Affairs. It was also noted that Tim Espich is doing great work to connect the incarcerated veterans with the

appropriate county service officers. Cuyahoga County Veterans Service Office is now connecting with service workers to establish links with those veterans that are now returning to society and supplying them with security deposits and funds for six months to get them back on their feet. Dan Weist noted that this 'pilot program' is working well for them.

Merle Pratt announced that October 1st is the next Council meeting. Subcommittees 2 and 4 will provide brief backs at that time. The building of the final report will begin at the October 15<sup>th</sup> meeting. Please modify or add, at will, during this process to assist with moving forward on the recommendations as a whole.

Jon Warmeling requested feedback from Representative Fessler regarding a letter she mailed out to each of the County Veterans Service Officers. # **Recommendation Approval**
